Top 10 Frequently Asked Questions

- I. What is the strategic value to working with M|SOURCE?
 - a. M|SOURCE transfers high volume, lower dollar value facility related tasks, which are not core to the client's line of business, to M|SOURCE.
- II. Will our company see a savings when contracting with M|SOURCE?
 - a. Yes
- III. Does M|SOURCE allow input on the selection of sub-contractors?

- IV. How will the invoice process work?
 - a. If your finance department will allow, M|SOURCE will submit an electronic invoice (.csv) providing all the cost center, account, units and cost information needed in a format to match your accounting system for a direct upload. Alternatively, M|SOURCE will accommodate all other normal billing processes.
- V. Will M SOURCE help us draft a standardized specification to cover all our sites? Can we include some site-specific requirement for unique conditions?
 - a. Yes and yes.
- VI. How many individuals will we be dealing with at M|SOURCE on a day to day basis?
 - a. One, even if you have 100 locations.
- VII. Regarding liability insurance, is there an advantage to having a primary (M|SOURCE) and secondary (subcontractor) structure? If you self-perform, the benefits are even greater.
 - a. Yes, there will be two layers of insurance. The sub-contractors will be required to list M|SOURCE and the Client as additional insured, and M|SOURCE will list the client as additional insured.

 - a. Yes, the credential is Certified Lawn Maintenance Technician "CLT".
 - IX. Does M|SOURCE leverage industry specific technologies to improve service delivery?
 - a. The short answer is yes. M|SOURCE uses several software applications and APPS.
 - X. What quantity of sites is M|SOURCE comfortable servicing?
 - a. M|SOURCE has serviced portfolios ranging from 5 locations to 250.
